Potential Health Effects (Acute and Chronic):

Chronic inhalation may cause effects similar to those of acute inhalation.

Inhalation: Material is irritating to mucous membranes and upper respiratory tract. Harmful if inhaled. Inhalation of high concentrations may cause central nervous system effects characterized by nausea, headache, dizziness,
