PAYMENT TERMS:

First order PRO-FORMA: Goods will be despatched once payment has been received. The goods will be held for a maximum of 2 weeks from the date of the invoice. If they payment for the goods has not been received within this time this order will be cancelled.

SUBSEQUENT ORDERS:

Once a credit account has been established our standard terms are STRICTLY NETT 30 DAYS FROM THE DATE OF INVOICE.

OVERDUE ACCOUNTS:

Goods will not be supplied to overdue accounts until the account is brought up to date. If the account remains unpaid after 60 days from the receipt of goods we reserve the right to charge overdue fees.

WARRANTY:

Aussie Soles Holdings Pty Ltd offers a 1 year limited warranty againts manufacturer's defects on Starfish, Starfish Fashion Strap, Indy & 3 months on all other fashion ranges sold at recommended retail price that have been supplied by Aussie Soles Holdings Pty Ltd. This warranty is conditional to defects in the quality of the product and not due to normal wear and tear. At Aussie Soles Holdings Pty Ltd discretion, the customer must return the defective product to Aussie Soles Holdings Pty Ltd., by packing it in the suitable postage satchel and posting it back with a valid sales receipt to show that the product purchased is within the warranty period. Aussie Soles Holdings Pty Ltd reserves the right to replace or repair a product under warranty without cost to the buyer.

EXCHANGES:

All exchanged must be made at place of purchase according to the place of purchases trading terms and conditions. Purchases made via the Aussiesoles.com website can be exchanged within 7 days of receipt of goods supplied. The customer must return the product to Aussie Soles Holding Pty Ltd., by packing it in the suitable postage satchel and posting it back with a valid sales receipt to show that the product purchased is within the exchange period.

RETURNS:

Aussie Soles Holding Pty Ltd will not accept any returns unless the goods supplied were faulty on receipt, or supplied incorrectly. Should the purchaser wish to return any goods for the above mentioned reasons, the purchaser should advice Aussie Soles Holding Pty Ltd or there appointed agent within 7 days of receiving consignment. Approval by Aussie Soles Holdings Pty Ltd must be given if the goods are to be returned past 14 days from the date of the invoice.

Goods are to be returned in their original state. Packaged to insure no further damages occurs, together with the customer's note for credit. The goods are to be posted via standard postage direct to Aussie Soles Holding Pty Ltd mailing address. 3/4 Lysaght Street Coolum Qld 4573.
