1) Your delivery of products to MintUnderground.com for consignment and your signature of this Consignment Agreement constitute a representation and warranty from you to MintUnderground.com that one of more of the following is/are true:

- a) You are the owner of the copyright in the content by transfer and/or purchase from the copyright owner(s).
- b) You created all content of the products yourself and own all copyrights in such content.
- c) You have a direct or implied enforceable license from all copyright owner(s) of the content of the products.
- d) The content of the products are in the public domain or have been abandoned to public use or are not copyrightable.

You represent and warrant that you have the full legal right to sign this Agreement, to perform your obligations under this Agreement, and to provide the consigned products to MintUnderground.com according to the terms and conditions of this Agreement; and the consigned products do not violate the intellectual property or other rights of any third party.

- 2) MintUnderground.com to make your consigned product(s) available for sale in its online store as it determines for 6 months or until such time as either you or MintUnderground.com terminates this Agreement
- 3) Stocking of the consigned product(s) is at the discretion of ww.mintunderground.com. MintUnderground.com does not guarantee any minimum number of copies stocked in any store or any volume of sales.
- 4) The term of this Agreement (the "Term") will begin on the date you sign this Agreement and continue for one year or until terminated by either you or MintUnderground.com, by giving written notice to the other. If you terminate the Term of this Agreement, MintUnderground.com will have 60 days from the date of receipt of your notice of termination to make final payment to you and to make all unsold products available to you. You will have 60 days from the date of MintUnderground.com's notice of availability to pick up all unsold products or the products will become the property of MintUnderground.com.
- 5) If you fail to provide MintUnderground.com with a current address and phone number, MintUnderground.com will not be responsible for failure to send notices or payments to you.
