Performing facial surgeries on cleft defects and other types of deformities to those in need. These services are performed by a team of medical professionals traveling to third world countries as volunteers. All work is entirely for gratis. In 2011 they performed 146 procedures, trained residents from UC Davis and the and local doctors and nursing staff in local hospitals in respective countries.
