Thank you for partnering with Style Exchange Boutique ("SEB"). It is our goal to make you the most money from your pre-loved designer and luxury items. Please understand that our client's preferences and our current inventory must be our selection guidelines. We base prices on Brand, Condition, Style and Demand. We strive to get the best possible price for you and will price according to demand, brand and condition. SEB will showcase your items in-store and possibly online, and via our social media pages. SEB reserves the right to donate items found to be soiled, damaged or defective. Items are left at your own risk. SEB is not responsible for theft, damage due to fire, vandalism, accidental damage, or unavoidable causality.

**PROCEEDS AND TERMS OF SALE:** Our consignment period is 90 days. However if SEB determines a longer period may be necessary to get the best return on your items, we may offer an extension on your contract. This will be determined at the end of your first 90 day consignment period and must be done in person during the week outlined above. All prices and deductions are done at the discretion of SEB. We reserve the right to run sales and promotions to drive sales. For any items sold UNDER \$100, the Consigner will receive 40% of the selling price. For any items sold OVER \$100, the Consigner will receive 50%. For any items sold over \$600, a reserve price will be set @ drop-off. The consigner may use their account balance at any time during the consignment period as a store credit and get 15% extra on their balance or you may pick up a check at the boutique during business hours with a 24 hour notice. In the event that you are not able to come in the boutique to pick up a check and it must be mailed to you, a \$2.00 mailing fee will be assessed. **CHECKING ON YOUR ACCOUNT:** You may call the boutique consigner line outlined above or stop in person to check on the status of your account. All consigner inquiries are streamlined to this line. ALL earnings must be collected within 6 months of the end of the consignment agreement. **SEB will charge a One Time fee for the life of your consignment agreement of \$20 which can be paid up front, taken out of your first earnings, or paid upon retrieval of unsold items.** There will be a 10% (of our ticket price) early retrieval fee per item assessed by the consigner if they choose to retrieve any items on consignment prior to the end of their consignment end period.

If you choose to pick up or extend your unsold LUXURY items (priced \$75+), you have a (1) week window (outlined above) to do so by stopping in person to the boutique to see if your account is eligible to be extended. It is the responsibility of the Consigner to keep track of their expiration week. SEB will not contact the Consigner about unsold, expired items. Items not picked up after the final pick up date on this agreement will become property of SEB: such items may be donated to a charity of SEB's choice or reintroduced into the inventory as store owned items. There are no exceptions to this policy!! Currently, we are working with Dress for Success and various local churches/shelters in the area for acceptance of donations. Giving back to our community is very important to us!
