## **Installation Instructions**

Transmission Skid Plate for Subaru Crosstrek 2013-2017 and Forester 2014-2018 PN: RTEK-100092	
Suggested tools	<ul> <li>Ramps or jack stands</li> <li>Jack</li> <li>Hand tools</li> </ul>
Safety Warnings	<ul> <li>Always support the vehicle with jack stands before working underneath</li> <li>Use only the parts supplied by RalliTEK to install this kit</li> <li>Check ALL the fasteners for tightness before and after road testing the vehicle</li> <li>Do not use an air impact wrench with reinstalling bolts as stripped threads may occur</li> </ul>

RalliTEK SKID PLATE INSTALLATION	
<ol> <li>Locate the front mount and install the M8X1.25 U-Nuts making sure that they are all oriented the same direction. The plate is symmetrical so either side can be the top side.</li> </ol>	
2. With the notches in the mount plate facing the front of the vehicle, slide the mount plate onto the top of the engine skid plate. Using 4 of the 20mm long bolts install the mount plate to the engine skid plate. Do not tighten the bolts at this time.	
3. While holding the transmission skid plate in place, install the remaining 20mm long bolts on the front of the skid plate. Do not tighten the bolts at this time.	
<ul> <li>4.</li> <li>a. Rotate the rear of the skid plate up and install the longer 50mm long bolts. Do not tighten the bolts.</li> <li>b. Tighten all of the bolts starting at the front and work towards the rear.</li> </ul>	

## **One Year Limited Warranty**

The purchaser shall notify **RalliTEK** at 888-773-1212 of any defect within the warranty period no later than thirty (30) days after purchaser discovers the defect. Should any failure to conform to this warranty appear within the warranty period, RalliTEK shall, on notification, correct the nonconformity at its option, either by repairing any defective part, or by making available, FOB RalliTEK plant, a repaired or replacement part. The purchaser must insure any defective item being returned because RalliTEK does not assume risk of loss or damage while in transit. No payment or reimbursement shall be made for installation, removal, transportation or other charges. The remedies set forth in this instrument are exclusive, and the liability of RalliTEK with respect to any sale shall not exceed the price of the product on which the liability is based.
