Do not use an air impact wrench with reinstalling bolts as stripped threads may occur

REMOVAL OF FACTORY SPLASH GUARD

1. Remove the clips and bolts to remove the factory plastic splash guard. These will not be reused

2. Locate slotted brackets on the radiator support



3. Insert the u-nuts onto the mounting plates and slide them into the factory bracket as shown.





4. Remove the two bolts securing the sway bar support bracket to the subframe

5. On non turbo applications it will be necessary to remove the lower portion of the OEM exhaust heat shield and may require bending the upper heat shield toward the exhaust between the red lines as shown in the image on right.

A small ball peen hammer works well for bending the upper heat shield if necessary.

Secure the upper heat shield with the OEM clamp at the front and the 2 x OEM 10mm bolts midway down.

When this is complete replace sway bar support brackets.



6. Slide the skid plate underneath the bumper cover and thread the supplied hardware into the u-nut on the mounting plate.

The supplied hardware to be used in this location

M8x1.25x20 - normal installation M8x1.25x25 - with RalliTEK Dome washers.

*These bolts will be difficult to start. The shorter hardware is necessary to avoid contact with the radiator lower registration pins.



7. Slide the supplied 20mm spacers between the skid plate and sway bar support bracket one at a time and begin installing the M10x1.25x35 bolts
