The ROAD iD 2019 12 Days of Christmas TRIVIA CHALLENGE (the "Contest") starts at 12:01 AM Eastern Time ("ET") on DECEMBER 8th, 2019 and ends at 3:00 AM PT on DECEMBER 20th, 2019 (the "Promotion Period"). The Contest is sponsored by ROAD iD, Inc., 35 West 8th Street, Covington, KY 41011 ("Sponsor") and is subject to all applicable U.S. federal, state and local laws, and provincial or territorial laws, and is void wherever prohibited by law.
