Agreement Terms

- *Must provide business resale certificate (FEIN#). Products purchased from KLASS under wholesale are exempt from tax. * Retailers are responsible to properly tax products upon retail sale.
- Products can be sold online, at trade shows or to other resellers when approved by KLASS.
- Products are never to be sold below wholesale unless approved by KLASS Cosmetics, LLC.
- Retailers will not alter KLASS products or packaging for KLASS products in any way.
- Retailers will not engage in any trade practice which could injure the reputation of KLASS or any KLASS product.
- ALL sales are final, we do not accept returns. Only defective, damaged or mismarked items will be replaced or refunded within 7 days of delivery.
- No warranties are to be offered on any products.
- Repackaged or altered items are not covered under manufacturer limited product liability.

Orders

- Opening order is \$500
 - Re-Orders: To be considered a wholesale order (50% off), retailers must purchase \$200 or more to receive wholesale pricing PER order. To maintain wholesale status, retailers must purchase \$1,000 per year.
 - Orders will be shipped 1-3 business days from the time of purchase. *Out-of-stock products will be refunded and retailers will be alerted when the item is back in-stock to reorder.
 - KLASS uses FedEx and USPS as shipping providers. Shipping rates are determined by weight of order. Expedited shipping is available upon request for an additional charge.

Accepted Forms Of Payment

- All orders must be prepaid by corporate credit card, bank check or money order. Personal or company checks will be held for clearance. Payment by corporate MasterCard, Visa, American Express and Discover is accepted.

Returned Checks and Order Cancellations

- There is a \$35 fee for any returned check. A 25% service charge will apply to any cancellations.

KLASS ACT Requirements
