INDICATIONS

For prolonged relief of discomfort due to minor irritations of the eye from exposure to wind, sun, water or other irritants. For use as a lubricant and protectant against further irritation or to relieve dryness of the eye. **Do not use beyond expiry date (☒).**

DIRECTIONS

Wash hands before use. Do not use after the expiry date. Instill 1 drop in the affected eye(s) as needed. While looking in a mirror, gently pull down lower eyelid and instill 1 drop on the inner surface of the eye or directly to the corneal surface of the eye by leaning back to a horizontal position. After application, shake any remaining droplet from tip of bottle and replace cap securely. Store in a cool, clean dry place.

TIPS FOR USE

1. Invert the bottle and squeeze it gently until a drop forms on the tip. This may take a couple of seconds as the solution needs to travel through the one-way-valve system.
2. With the drop suspended at the tip, carefully bring the bottle above your eye and squeeze gently until it falls into the affected eye.
3. Please note: After use, there may be a residual amount of liquid remaining on the blue tip. This confirms that the bottle is working as it was designed, and not drawing this liquid back into the bottle.

If any residual solution remains on the bottle after use, simply flick it off with a brisk motion and close the cap tightly.

This step is critical in keeping the remaining solution sterile and safe. Even a minuscule amount of fluid, exposed to a non-sterile external environment, may become contaminated.

COMPOSITION

I-DROP® MGD is a sterile, preservative-free, blink-activated viscoadaptive lubricating eye drop and **contains:** water for injection, phosphorylcholine polymer, sodium chloride, sodium phosphate, glycerol, sodium hyaluronate.

WARNINGS

If you experience eye pain, change in vision, continued redness or irritation of the eye, or if the condition worsens or persists for more than 72 hours, discontinue use and consult a doctor.

I-DROP® MGD may modify the effect of other solutions or drugs that you may be using on the eye. This product has not been tested during pregnancy or lactation. Do not apply I-DROP® MGD on an infected eye.

Do not operate machinery or drive a vehicle immediately after use. To avoid contamination, do not touch tip of container to any surface. Do not use this product if you are allergic to any of the ingredients. Replace cap after use. Keep the bottle closed tightly. Not for use with contact lenses. Do not use if bottle appears damaged or compromised.

KEEP OUT OF REACH OF CHILDREN.

HOW IT'S SUPPLIED

I-DROP® MGD is supplied in a bottle with a fill volume of 10 mL. Do not use if the packaging is damaged.
