3. The Seller undertakes to use its best endeavours to adhere to specified delivery dates. The Seller shall not be bound by any estimated delivery dates contained in any order acceptance, and does not accept liability for any loss, injury, expense consequential or any other damages whatsoever resulting from any delay in delivery, nor shall any such delay in delivery entitle the Purchaser to cancel any order or to refuse acceptance of delivery at any time without the Seller's prior written consent. Unless otherwise agreed, delivery will take place at the premises of the Seller.
