



THIS CONSIGNMENT AGREEMENT STATES THE TERMS AND CONDITIONS THAT GOVERN THE CONTRACTUAL AGREEMENT BETWEEN ANTOINETTE, (THE "CONSIGNEE") AND _____, THE "CONSIGNOR") WHO AGREE TO BE BOUND BY THIS AGREEMENT.

WHEREAS, THE CONSIGNOR OWNS RIGHT AND TITLE TO THE ITEMS DESCRIBED ON EXHIBIT A ATTACHED HERE TO (THE "CONSIGNEE ITEMS"), AND THE ANTOINETTE DESIRES TO TAKE POSSESSION OF THE CONSIGNEE ITEMS WITH THE INTENTION OF SELLING IT TO A THIRD PARTY.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND PROMISES MADE BY THE PARTIES HERETO, THE CONSIGNOR AND ANTOINETTE (INDIVIDUALLY, EACH A "PARTY" AND COLLECTIVELY, THE "PARTIES") AGREE TO AS FOLLOWS:

1. RIGHT TO SELL.

THE CONSIGNOR HEREBY GRANTS TO ANTOINETTE THE EXCLUSIVE RIGHT TO DISPLAY AND SELL THE CONSIGNEE ITEMS ACCORDING TO THE TERMS AND CONDITIONS OF THIS AGREEMENT.

2. MINIMUM PRICE.

THE MINIMUM PRICE AT WHICH THE CONSIGNEE MAY SELL THE CONSIGNEE ITEMS SHALL BE

_____ (THE "MINIMUM PRICE"). IN THE EVENT THE CONSIGNEE SELLS THE CONSIGNEE ITEMS FOR LESS THAN THE MINIMUM PRICE, THE CONSIGNOR SHALL BE ENTITLED TO THE SAME PAYMENT THE CONSIGNOR WOULD RECEIVE AS ITS SHARE OF THE SALE PRICE UNDER THIS AGREEMENT HAD THE CONSIGNEE ITEMS BEEN SOLD FOR THE MINIMUM AMOUNT.

3. CONSIGNMENT FEE & PROCESSING

ANTOINETTE SHALL BE ENTITLED TO 15% OF THE FULL PURCHASE PRICE OF THE CONSIGNED ITEMS (THE "CONSIGNMENT FEE").

FURTHER MORE, THE CONSIGNER WILL ALSO BARE A 4% PROCESSING FEE ON THE SALE OF HIS/HER ITEMS. THIS PROCESSING FEE IS DETERMIND BY THE NET SALE. WITHIN 12 DAYS FROM THE SALE OF THE CONSIGNED ITEM(S), ANTOINETTE SHALL DELIVER TO THE CONSIGNOR THE SALE PRICE OF THE CONSIGNED ITEMS LESS THE CONSIGNMENT FEE & PRCESSING FEE.

4. INSURANCE.

ANTOINETTE REPRESENTS AND WARRANTS THAT ANTOINETTE SHALL MAINTAIN INSURANCE COVERAGE SUFFICIENT TO COMPENSATE THE CONSIGNOR FOR THE FAIR MARKET VALUE OF THE CONSIGNED ITEMS IN THE EVENT OF DAMAGE DUE TO FIRE, THEFT, OR OTHERWISE WITHIN ANTOINETTE'S POSSESSION.

5. LOCATION OF ITEMS.

ANTOINETTE AGREES AND ACKNOWLEDGES THAT THE CONSIGNED ITEMS SHALL ONLY BE KEPT AND STORED AT ANTOINETTE'S PREMISES UNLESS OTHERWISE AGREED UPON BY THE CONSIGNOR IN WRITING.

6. TIMEFRAME.

IN THE EVENT THAT ALL THE CONSIGNED ITEMS ARE NOT SOLD WITHIN 1 YEAR ALL UNSOLD CONSIGNED ITEMS WILL BE ARRANGED TO MEET UP WITH ANTOINETTE OR SHIPPED BACK AND SHALL BE RETURNED TO THE CONSIGNEE WITH ALL DELIVERY COSTS BORNE BY THE CONSIGNER.

7. CONSIGNOR REPRESENTATION.

THE CONSIGNOR HEREBY REPRESENTS AND WARRANTS THAT THE CONSIGNEE HOLDS FULL TITLE (OR HAS RECEIVED, IN WRITING, THE AUTHORIZATION TO SELL THE CONSIGNED ITEMS BY ANY NECESSARY PARTIES) TO THE CONSIGNED ITEMS.

8. EXPENSES.

ANTOINETTE SHALL BEAR ALL EXPENSES FOR SHIPPING THE CONSIGNED ITEMS TO CUSTOMERS.

9. NO MODIFICATION UNLESS IN WRITING.

NO MODIFICATION OF THIS AGREEMENT SHALL BE VALID UNLESS IN WRITING AND AGREED UPON BY BOTH PARTIES

10. SHIPPING.

ANTOINETTE IS NOT RESPONSIBLE FOR ANY LOST OR STOLEN PACKAGES COMING INTO ANTOINETTE FOR CONSIGNMENT OR BEING RETURNED TO THE CONSIGNOR BY SHIPPING SERVICES.
