Reporting - Support from Leadership

Dominion City will work to identify and preempt problems before they happen. Employees who are concerned or unsure about appropriate conduct are asked to speak with a member of the management team to help guide them.

Employees who wish to share concerns anonymously can do so by reporting concerns to Jalapeno Employee Engagement, a third-party HR services provider retained by Dominion City. Employees are reminded of their duty to report any health and safety concerns or violations immediately, including instances of harassment, discrimination or violence in the workplace.
