— OPERATING INSTRUCTIONS FOR YOUR KBD-FIJI SUN LAMP—

CAUTION: PROTECT YOUR EYES - WEAR PROTECTIVE EYEWEAR

To avoid injury to eyes, protective eyewear must be worn by all persons in the room during lamp operation.

- Put on protective eyewear
- Place unit 18" (inches) from skin
- Plug unit into 120 volt 244 volt (50Hz/60Hz) power source
- Set timer to 15 minutes
- Turn power switch to on position
- Follow recommended exposure / maintenance schedule
- Unplug lamp for storage and service

DANGER: Ultraviolet Radiation, so follow instructions and avoid overexposure. As with natural sunlight, overexposure can cause skin injury and allergic reactions. Repeated exposure may cause premature aging of the skin and skin cancer. Wear protective eyewear, failure to do so may result in severe burns or long-term injury to the eyes. Different skin types require different exposure times and distances. The figures given for time and distances are safe for average skin, Type III. Do not exceed 3 exposures per week during tan build up. Initial exposure should not exceed 3 minutes for Type II skin or 4 minutes for type III, IV, or V skin at a distance of 18" per session. Exposure at distance less than 18" is not recommended. Distance is determined from metal guard, not light bulb.

Skin type I individuals, defined as one who "always burns easily: never tans (sensitive)" are advised not to tan. Less photosensitive skin types, while able to tolerate higher exposure doses without burning, also, by definition tan more easily and should not require greater exposure to achieve or maintain a tan. Consequently all other skin types (II-IV) use the same exposure schedule.

NOTE: Reddening or sunburn is usually not visible until 4-8 hours after exposure.

KBD, INC. HISTOLOGY

SPERTI SUNLAMP (manufactured/owned by KBD, Inc.), has been manufacturing tanning lamps since the 1930's. The original Sperti Sunlamp consisted of a filtered intermediate pressure mercury lamp, approved by the AMA in 1940 as a sunlamp. Today's KBD FIJI Sun Lamp is an updated version utilizing fluorescent technology, specifically formulated to produce ultraviolet energy in the specific SKIN TANNING range and eliminating any harmful UVC energy. In order to comply with modern safety guidance, the fifteen (15) minute timer provides an exposure, at 18" (inches) from the user's skin, of 1 (one) Standard Erythemal Dose (SED). The SED is an internationally standardized measure of UV radiation equivalency.

TUBE REPLACEMENT INSTRUCTIONS —

(Recommended Annually)

Tools required: Phillips Head Screwdriver

- Step 1 Remove table stand. Position unit on a flat surface with wire guard facing ceiling.
- Step 2 Remove wire guard by compressing either side away from the metal housing.
- Step 3 Top of unit is the end WITHOUT the timer/switch. Remove the top front screw from both sides of the unit. Remove the only screw on the top of the unit.
- Step 4 Remove the top panel.
- Step 5 Rotate each bulb 1/4 turn either direction. Gently pull top of tube toward you. Lift out of base connector. Remove all tubes in this manner.
- Step 6 Align bottom pins of replacement tube front to back and insert into bottom lamp holder. Seat top set of pins by pushing into top lamp holder.
- Step 7 Rotate each tube 1/4 turn making sure the label/etching is facing you. You will notice the "lighter" part of the tube is in the back.
- Step 8 Replace top panel and wire guard.

After all tubes are replaced, your FIJI SUN lamp can be restarted.

FIJISUN & D/UV-4F VITAMIN D UNITS

SUBJECT: Fluorescent tubes do not ignite.

During the delivery process issues may occur preventing tube ignition.

PLEASE:

- 1. Check to be sure the tubes have not become "dislodged". If so, please reinstall the tubes.
- 2. Check plug for a snug fit into the appliance—thoroughly inserted into the unit.
- 3. Confirm electric outlet is energized.
- 4. Set timer to the maximum time, click on/off switch to the on position. Wait 3 seconds and click the switch to the off position. Repeat this procedure at least 8 to 10 times. Cycling the tubes with the on/off process allows any debris on the tube filaments to be cleared. This lighting process will not be required for future use.
