



Adding an Authorised Representative

Complete this form if you want to authorise another person to act in your behalf on your Spacetalk Mobile account. To protect your privacy this form needs to be signed by an authorised witness. An authorised witness is a solicitor or barrister, doctor, police officer or Justice of the Peace.

We will also accept a person who holds a formally determined Power of Attorney or Guardianship Order. Please forward a certified copy of the Power of Attorney or Guardianship Order together with this form (signed by the Attorney or Guardian for the customer). We may need to have the documents checked before we can accept the appointment.

WHAT CAN AN AUTHORISED REPRESENTATIVE DO?

An authorised representative can act on your behalf and access your personal information on your Spacetalk Mobile account. They can edit your contact details, make changes to your prepaid plan, edit payment details, and have the ability to connect and disconnect your services.
