







INSTALLATION (Phone Holder) Step 4: Secure your smart phone into holder by opening spring adjusted flaps. Do not force.



HOW TO USE (Wireless Remote Shutter)



- 1. Turn on the power button (located at the side of remote), indicator LED flashes and "AB Shutter3" will enter into pairing mode.
- 2. Turn on your smartphone's Bluetooth settings and search for "AB Shutter3" name.
- 3. Select the device "AB Shutter3" from the list and pairing will be finished automatically in a few seconds.
