Studio Introduction

Long-term programs are 12, consecutive-week classes based around our 4 themes: Art History, Nature, Daily Life, and Inspiration. Each theme is covered over a 3-week period and members will complete, on average, 4 projects per 12-week session. Each project will go through a draft, 2D rendering in mix media, and then 3D art-making process.

Admissions

The Studio admits members on a rolling 3-week basis to coincide with our curriculum. New members schedule an introductory meeting (30 mins) with Clay House Art Staff as well as read and sign the registration and studio policy documents before we schedule your first day.

Tuition and Refund Policy

Tuition includes all materials and instruction. Tuition must be paid before the start of the member's first class. Tuition is non-refundable after the member's first class.

Missed Class Policy

Per 12-week session, you will be able to schedule 2 make-up sessions. Please call at least one week in advance to reschedule a missed class for vacation. If you are going to miss more than two (2) consecutive classes, call Clay House Art staff to pause your membership. There are no refunds for unexcused missed classes. If you believe you are going to be late or miss the class please call us prior to the class start time to avoid any penalties.

Cancellation Policy

Clay House Art reserves the right to cancel any class for any reason. Students enrolled in a class, which is canceled, will be notified by phone or email. Students enrolled in a canceled class will be offered a class credit or refund for the class.
