Shipping Charges

Shipping options are provided at the time of checkout. We offer a combination of USPS First Class Package, USPS Priority Mail, UPS Ground, FedEx Ground Home Delivery, and FedEx Standard Overnight. Charges are calculated upon weight. Actual charges are displayed in checkout.

Shipping Carriers

The carrier we use for Standard Domestic is USPS, United Parcel Service (UPS), and FedEx.

Delivery Information

Furbliss.com ships most orders within one business day of receipt. Shipping options are provided at the time of checkout.

Next-Day shipping is available. Next-day rates will be calculated at time of checkout. All expedited orders ship on the next business day.

Product Returns/Exchanges
