Be sure to turn off the headset after use to avoid draining the battery.

- To avoid injury to your ears, lower the volume level before putting on the headphones.
- Avoid listening at high volume for long periods of time.
- Do not listen to headphones while cycling, driving a vehicle, or operating machinery

Wireless Listening:







Wireless Listening

■ Transmitter adjustment

For the transmitter, mount $3 \times AAA$ batteries according to the engraved polarities in the battery case, or use the external 5V/150mA AC adapter.

A: When you listen to TV, put the plug ② and ③ in the audio-out jack of TV, put plug ① to transmitter and set the volume in proper status. When you listen to PC or other audio device, connect Cable 1 and Auxiliary Adapter, then put plug ① to transmitter and plug ④ to earphone jack or audio out jack, and operate the volume of audio device properly.

B: Switch on the transmitter, the power indicator LED will be on.

■ Receiver adjustment

For the receiver, mount $2 \times AAA$ batteries as polarities instruction engraved in the battery case.

A: Switch on the receiver, adjust the volume properly.

B: Press the RESET button and hold one second, then press the SCAN button, and hold one second, if the connection between the transmitter and the audio device is correct, you can receive the signal sent out from the transmitter. You can repeat pressing the RESET and SCAN buttons again and again, until the effect is perfect.

Turn off

After using, turn off the transmitter and receiver. Take out the batteries and disconnect the cables when not in use for long periods of time.

Using the Earbuds

To listen to audio via the earbuds, simply insert the 3.5mm plug into the audio-out jack of your audio player.

Trouble Shooting

Phenomena	Causes	Eliminating Means
The audio signal can't be received	The power of the transmitter is not turned on.	Turn on the transmitter.
	The transmitter isn 't connected with the audio set properly	Connect the transmitter and audio set properly.
	The distance of receiver is beyond the transmission range.	Receive the signal in the trans- mission range.
Noise	The power of batteries in the receiver/transmitter is too low.	Replace the old batteries with new ones.
	The audio signal from your audio set is too strong or too weak.	Adjust the volume of your audio set properly.
	Severe interference occurred in the AC power supply-line.	Power off the interferent, or use another AC power supply-line. Or relocate the AC adapter cord, the audio cable and antenna of the transmitter.
Difficult to receive the audio signal	The power of batteries in the receiver/transmitter is too low.	Replace the old batteries with new ones.
	The receiver is moved too quickly.	Slow down or stop moving the receiver.
