SAFETY INSTRUCTIONS

Please be sure to read the following instructions before using the Bluetooth Headphones:

1. The device is not intended for use by persons (including children) with reduced physical, sensory or mental capacity. Persons who have not read the manual, unless they have received explanations by a person responsible for their safety and supervision, should not use this device.
2. Children should be monitored to ensure that they do not play with the device.
3. The device should always be readily accessible.
4. The device should not be exposed to dripping or splashing water.
5. Always leave a minimum distance of 10 cm around the unit to ensure sufficient ventilation.
6. Open flame sources, such as candles, should not be placed on top of the device.
7. The device is intended for use only in a temperate climate.
8. At full volume, prolonged listening to the portable audio device may damage the user's hearing and cause hearing trouble (temporary or permanent deafness, hearing drone, tinnitus, hyperacusis).

2. Only use batteries, chargers and other accessories which are compatible with this equipment. Do not connect incompatible products.

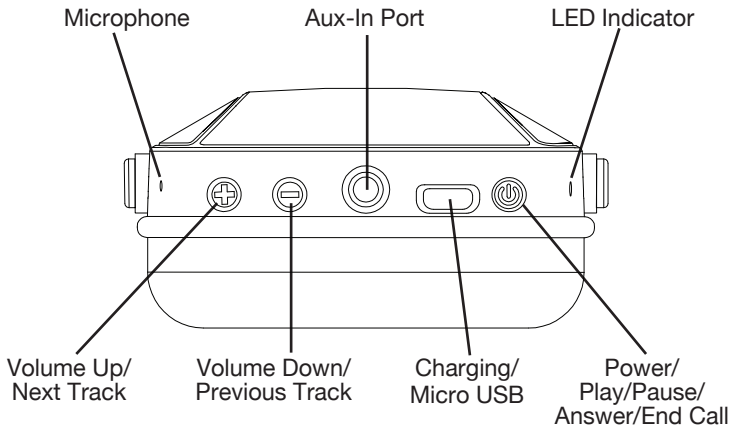
KEEP THE EQUIPMENT DRY

FUNCTIONS



POWERING HEADPHONES ON & OFF

1. Press and hold Power Button (⏻) to power ON or OFF.
NOTE: Powering ON: LED will illuminate PURPLE then flash BLUE, Powering OFF: LED will illuminate PURPLE, then turn off.
2. Listen for audible tone. (LED will not illuminate when Headphones are off.)

To Change the Audio Track:

1. Press and hold (+) to go to the next track.
2. Press and hold (-) to restart current track. Press and hold (-) again to go to previous track.
3. Quickly press the Power Button (⏻) to pause current track.

Volume:

1. Press (+) button incrementally to increase volume.
2. Press (-) button incrementally to decrease volume.

CHARGING THE BATTERY

1. Connect USB cable to general USB Power Supply.
2. Connect charger to the outlet.
3. When the charger is connected to the headset, the LED indicator light will remain lit RED. The Headphones will be fully charged in 4 (four) hours. The LED indicator will turn BLUE and remain lit.
4. Once fully charged, disconnect the charger from the headphones and outlet. The headset is now ready for use.

NOTE: The fully charged battery has power for around 5 hours of talk time, 4.5 hours music play time, and up to 200+ hours of standby time. However, both talk and standby times may vary when used with different mobile phones or other compatible Bluetooth devices, usage settings, usage styles, and environments. When the battery power is low, the headset will give a "Low Battery" alert every 20 seconds and the red indicator light will start to flash. When using the headphones with an iPhone, an additional battery meter will be shown with the remaining battery capacity displayed on your phone.

CAUTION:

The built-in rechargeable battery is not replaceable. Do not remove or replace it, do not throw in the trash or in a fire. Do not dispose device in standard garbage disposal sites. Dispose of device at available Battery Recycling Sites after fully discharging battery. Not doing so may violate local disposal laws and regulations. Please refer to local regulations for proper battery disposal.

PAIRING THE HEADPHONES TO BLUETOOTH

Before using the headset for the first time, you must pair the unit with a Bluetooth enabled device. Pairing is a one-time process and is required only for the first connection with the mobile phone.

1. Keep headphones within a 33 ft (10 m) range of a Bluetooth enabled device.
2. Press and hold the Power/Play button (Ⓜ) for about 5 seconds until the indicator light will flash red and blue intermittently. The device is now in pairing mode.
3. Find the Bluetooth settings of your mobile phone and search for available Bluetooth devices.
4. Choose “VSG-160” from the list of available Bluetooth devices.
5. If required, enter the PIN code “0000” and confirm the entry. Once the pairing process is successful, the headphones will connect to your device automatically. The indicator light will flash blue every 5 seconds when the headset is in standby mode.

AUX-IN FUNCTION

1. Use the included 3.5mm AUX-IN cable to connect the Headphones with an audio device such as an MP3/MP4 player, smartphone or tablet.
2. Your Audio device (MP3/MP4 player, smartphone or tablet) controls the music playback.
3. Adjust the volume on your device.

NOTE: Volume controls on the headphone will be deactivated when using the AUX-IN function.

PHONE CALL FUNCTION

Answer: Press the Answer button (Ⓜ) quickly to answer the incoming call.

Reject: Press and hold Answer button (Ⓜ) for 2 seconds to reject the incoming call.

End a call: Press the Answer button (Ⓜ) quickly to end a call.

Re-dial last number: At standby status, double press Answer Button (Ⓜ) to re-dial the last number.
