

EDGE OF SHELF



BEFORE INSTALLING THE SHELVES TO A WALL, PLACE THE METAL BARS INTO EACH SHELF BASE BY PUSHING FIRMLY UNTIL SECURE.

USE THE ABOVE GREY INSTRUCTION TEMPLATE TO MARK WHERE EACH SHELF WILL BE ANCHORED IN PLACE.

TIP - USE A LEVEL OR A SMARTPHONE APP FOR ACCURATE LEVELING.

4x SELF DRILLING WALL ANCHORS



CAREFULLY USE A PHILLIPS HEAD SCREWDRIVER TO DRIVE THE SELF DRILLING WALL ANCHORS INTO THE MARKED WALL POINTS.


