



## Dog Training Services Agreement

This agreement between \_\_\_\_\_ Hereinafter referred to as "Client" and Julie Parker acting as agent for Rocky Mountain Dog Training, LLC (hereinafter known as "Trainer" pertains to the following:

For good and valuable consideration, the parties agree as follows:

### Training Fees:

a: Client agrees to pay Trainer a nonrefundable fee in the amount of \$ 195 for a package of 6 sessions, to be paid at contract signing or prior to the first session.

All sessions must be completed within **6 weeks** from the date of commencement of contract.

Please initial to indicate your understanding of the following items:

\_\_\_\_\_ No refunds or cancellations of this Agreement.

\_\_\_\_\_ If Client must miss a group class, please notify trainer via email to obtain written materials and video demos for the missed class. Make up sessions may be purchased at standard private rate.

\_\_\_\_\_ Lesson is forfeited for cancellations and no-shows. If client misses 2 or more sessions and is unable to schedule make up sessions to remain on track with the group's curriculum, the package is forfeited.

\_\_\_\_\_ Client is responsible for payment of all monies due as stated on this contract, whether or not they choose to complete any or all lessons.

\_\_\_\_\_ Trainer reserves the right to fire any Client without refund at our discretion for the following reasons:

- The Client is disrespectful or violent to our staff, clients, or their own family members or guests.
- The Client fails to pick up and properly dispose of pet waste and dispose of in and around the training center.
- The Client is disrespectful or violent to their dog or other client's dogs.
- The Client does not follow training instructions.
- The Client endangers any dog, animal, or human.
- The Client uses physical force or punishment with any animal or person.
- The Client uses choke chains, pinch collars, any form of shock equipment or retractable leads during training. For more information on the danger of these tools, ask your trainer.

\_\_\_\_\_ Trainer may use photographs of Dog in web and print content i.e. Facebook, Website, Marketing.

Trainer agrees to provide 6 group private lessons for Client and Dog on a lesson-by-lesson basis, the goal being to teach the client how to obedience train and



work with Dog. These lessons will take place at Rocky Mountain Dog Training. The trainer will make every reasonable effort to help Client achieve training and behavior modification goals but makes no guarantee of Dog's performance or behavior as a result of providing professional animal behavior consultation. Client understands that he/she and members of the household must follow Trainer's instructions without modification, work with the dog daily as recommended, and consistently reinforce the training being given to Dog.

If Dog causes property damage, or bites or injures any dog, animal or person (including but not limited to Trainer and her agents), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred by Trainer and her agents and to defend and indemnify Trainer and her agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. If Dog is injured in a fight or in any other manner during or after the term of the Agreement, Client assumes the risk and agrees that Trainer should not be held responsible for any resulting injuries, losses, damages, costs or expenses.

At Trainer's sole election, Trainer's duties hereunder shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, or Client or Dog interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

This Agreement is binding upon Client, spouse of Client, and children of Client. This agreement supersedes all prior discussions, representations, warranties and agreements of all parties, and expresses the entire agreement between Client and Trainer regarding the matters described above. The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything else. Without limiting the generality of the foregoing, Client acknowledges that Trainer has not represented, promised, guaranteed or warranted that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the results of training will last for any particular amount of time. This Agreement may be amended only by a written instrument signed by both Client and Trainer. Any remedy provided in this Agreement is in addition to any and all other remedies provided by law or equity. If any provision of this agreement is invalid, void or unenforceable, they will be severed and the remaining provisions shall be given full force and effect.
