- Attendance of a free SafeWork NSW safety workshop, event, webinar or an advisory visit from a SafeWork NSW Officer. The free online webinars are most convenient... as you can check them out at a time that suits you.
- A receipt for payment in full for the goods (or proof of payment)
- Your business details including ABN, trading name and business bank account.

## How do I complete my application:

Within six months of attending the advisory visit, safety workshop, program or event, you must:

- identify, purchase and implement your eligible safety item, as per the <u>list of eligible</u> <u>items</u>. The <u>MOVI Standing Desk</u> falls under "Muscular stress" / "adjustable or tilting work bench, table, or work station"
- Get a paid tax invoice and receipt (or proof of purchase). The item must be purchased after you attend an eligible SafeWork NSW safety activity workshop, <u>event</u>, <u>webinar</u> or an advisory visit from a SafeWork NSW Officer.
- Complete an online rebate <u>application form</u> or print an application form and return it to us by:

  - post to Small Business Rebate, SafeWork NSW, Locked Bag 2906, Lisarow NSW 2252.
- Attach a copy of your paid tax invoice and receipt. The items you are claiming for must be paid for, received and installed prior to your application.
