Sub: Scrutinizer's Report on E-voting and Postal ballot conducted for Members of HIMALAYA FOOD INTERNATIONAL LIMITED (Formerly known as Himalya International Limited)

Pursuant to Section 108 and Section 110 of the Companies Act, 2013 and rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 for ascertaining the E-voting and Postal ballot for passing the below mentioned resolution

International Limited ("the Company") pursuant to, Section 108 and Section 110 of the Companies Act, 2013 and rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 for the purpose of Scrutinizing the E-voting and Postal ballot in a fair and transparent manner and ascertaining the requisite majority on e E-voting and Postal ballot carried out as per the provision of Companies Act, 2013 on the below mentioned resolution(s). We submit our report as under:

- 1. The e-voting period remained open from 02.06.2020 (9:00 a.m.) to 01-07-2020 (17:00 p.m.).
- 2. The Shareholders holding shares as on the "cut off" date i.e. 22th May 2020 were entitled to vote on the proposed resolutions (item no. 1 and 2 as set out in the Notice of E-voting dated 28/05/2020.) Voting rights has been reckoned on the paid-up value of shares registered in the name of the Members on May 22, 2020 (Cut-off date). Only those Members whose names are recorded in the Register of Members of the Company or in the Register of Beneficial Owners maintained by the Depositories as on the Cut-off date was entitled to cast their votes by e-voting.
- 3. The votes cast by e-voting were unblocked on 04.07.2020 pressing finalize Button. Voting result were downloaded and sent on the email ID of CS for record purpose.

- 4. Thereafter, the details containing, inter-alia, list of equity shareholders, who voted "For" and "Against", were downloaded from the e-voting website M/s Central Depository Services Limited.
- 5. The total numbers of Ballots received were 0 as due to cronavires pandemic, and relaxation proviso from MCA, only -voting process has been adopted by the Company, in Compliance of The Ministry of Corporate Affairs, Government of India ("MCA") in terms of the General Circular No.14/2020 dated 8 April, 2020, General Circular No. 17/2020 dated 13th April, 2020, General Circular No. 20/2020 dated 5 May,2020 and General Circular No. 21/2020 dated 11 May, 2020 ("MCA Circulars"), in view of the current extraordinary circumstances due to COVID-19 pandemic requiring social distancing, Company has sent mail to all its registered shareholders, whose email id is available. Company has also published the same in Public newspaper dated 02 June 2020 in a leading newspaper THE PIONEER and also request to register email for the said issue so that all shareholders can participate.

In compliance with the requirements of the MCA Circulars, hard copy of Postal Ballot Notice along with Postal Ballot Forms and pre-paid business reply envelope has not sent to the members for this Postal Ballot and they are required to communicate their assent or dissent through the remote e-voting system only. The said issue has also been intimated to BSE.
