

SETUP YOUR DEVICE

Using the micro USB charger provided, charge your device until the light turns **Solid red**, about 4 hours. We recommend charging the device fully prior to the first use.



The charging port can be found behind the Onyx+ under the rubber charging cover.

Insert the micro USB into the small hole at the back of the Onyx+.




USING YOUR DEVICE


1. Remove the RealFeel Sleeve from the hygiene plastic.
2. Remove the cap and the grip clip from the Onyx+.
3. Insert the RealFeel sleeve into the Onyx+ and use the grip clip to close the sleeve in place.
4. Apply a generous amount of lube inside the sleeve and on yourself.



**Please note: Opening the grip clip the first few times is quite tough. Try using a blunt object to get it open.



1. Power on by pressing the multifunctional button at the bottom of the device and hold for approximately 4 seconds.
2. A flashing blue color will show, and the device is now in Bluetooth Mode (go to page 7).
3. Push the button once. The light will flash purple and now the device is in Manual Mode (go to page 7).
4. Push the button once more. The light will be solid purple and now the device is in Automatic Mode (go to page 7).
5. To turn off the device, hold the multifunctional button for approximately 4 seconds until the light goes off.

MODES

Onyx+ has three (3) main modes; Bluetooth Mode, Manual Mode and Automatic Mode. To cycle through each mode, click the single multifunctional button until you reach the mode of your choice.

Onyx+'s default mode is Bluetooth Mode.

1. Bluetooth Mode; Indicated by a blue light ●

To pair Onyx+ with content, follow the instructions on the FeelConnect App.


Go to FeelMe.com, click on "My Devices" in the top right corner, and scan the QR code to connect to the content of your choice.

2. Manual Mode; indicated by a flashing purple light ●

Once the device is in Manual Mode, you can control the stroke by using the trackpad located on the front of the device. Swipe up to stroke up, and swipe down to stroke down.

3. There are 4 Automatic Modes; indicated by a solid purple light ●

CHARGING AND LED INDICATOR

1. Insert the USB cable into the charging port on the Onyx+. The charging port is located at the back side of the Onyx+.
2. Insert the other end into a USB port. This can be in a computer or wall adapter [Please note, wall adapter is NOT included in the box.]
3. Wait for the red LED light to blink slowly; this indicates that the Onyx+ is charging.
4. The LED light will glow solid red when Onyx+ is fully charged.
5. When the battery is low, the LED indicator will prompt you to charge by flashing red quickly. You will have approximately 5 minutes before Onyx+ disconnects from Bluetooth and turns off.
6. The LED indicator will blink blue-red-blue-red periodically if an update is available or if something has gone wrong.

Blinking BLUE ●	Bluetooth mode; searching to connect.
Solid BLUE ●	Bluetooth mode is connected.
Flashing PURPLE ●	Manual mode.
Solid PURPLE ●	Automatic mode.
Solid RED ●	Fully charged.
Blinking RED ●	Battery low.
Blinking RED ●	When on charge.
Blinking RED quickly ●	Battery is critically low- 5minutes until disconnect.
Blinking BLUE/RED ●●	Bootloader mode; Please update.

HANDLING

KIIRÖÖ recommends removing the sleeve from Onyx+ to apply lubricant. Apply a generous amount of water-based lubricant inside the sleeve before use.

Recommended:

Always use KIIRÖÖ Lube™ or any other water-based lubricant.

Always use lubricant as it will prolong the lifespan Onyx+'s sleeve and give you the most comfortable experience.

Do not use:

Silicone or oil-based lubricant as it will deteriorate the sleeve of the Onyx+.

Cleaning:

Always clean the sleeve thoroughly after each use.

Use warm water along with KIIRÖÖ Pure™ intimate toy cleaner, dish soap or a specialized toy cleaner.

Wipe the Onyx+ exterior with cleansing wipes as
