

## Distributor Terms and Agreements.

ASI Standards does not have any exclusive distributor agreements. By providing ASI Standards a Purchase Order, Credit Card, Intent to Pay, or accepting an ASI Standards Quote or Proforma Invoice, you agree to the following terms and conditions.

As a distributor, you are entitled to promote, submit quotations, participate in public tenders, and conclude orders on your own account.

The distributor activities must comply with the relevant clauses in ISO 17034. This includes handling, storage, labeling, and any claims. Each distributor must allow ASI to visit and inspect the activities related to the compliance to the ISO 17034 standard and instructions provided by ASI on the certificate of analysis.

Each approved distributor that sells material compliant with ISO 17034 must comply with the following items:

1. All domestic and internal shipping regulations (including hazardous/dangerous goods requirements)
2. All United States export laws and regulations
3. Proper storage and handling of ASI Standards (RM/CRM) which includes secure and appropriate storage facilities for the RM/CRM (ambient conditions)
4. The distributor must have a data system which allows the tracking of every RM/CRM unit and the customer information related to the sale in the event ASI has to contact the end user due to a recall or certificate change.
5. The distributor cannot alter, obscure, remove or conceal or otherwise interfere with labels applied by ASI. If the distributor covers the ASI label so that the ASI lot number or tracking number cannot be identified; no ISO 17034 certificate will be provided for that material.
6. The distributor will distribute the RM/CRM to end users using the appropriate packaging to ensure the RM/CRM arrives in an unchanged condition.
7. The distributor cannot make any claims for ISO 17034 (if they do not have the accreditation) or resell ASI standards without including ASI Standards with the accreditation symbol and certificate number to avoid any misrepresentation of the accreditation status of ASI Standards.
8. ASI Standards reserves the right to decline an order.

Distributor acknowledges and understands that the items purchased may be subject to United States export control laws and regulations and agrees to full compliance with any law or directive of the United States, including without limitation, the United States Export Administration Regulations (15 C.F.R. Sections 768 et seq.).
10. Distributor agrees to full compliance with any sanctions law or directive of the United States, including without limitation, the Regulations of the Office of Foreign Assets Control of the U.S. Treasury Department (31 C.F.R. Sections 500-599).
11. Distributor agrees to take any and all actions necessary to inform itself of the laws and regulations above-referenced and will obtain all necessary authorizations, licenses, or approvals from the appropriate government agency.
12. Distributor certifies that it will seek prior authorization from the U.S. government for the re-export, resale, or transfer to certain terrorist supporting and embargoed countries and the nationals of those countries which may be required.
13. Distributor acknowledges and understands that it will be subject to civil and criminal penalties for failure to comply with U.S. export control and sanction laws.
