SECTION 5: FIRE-FIGHTING MEASURES

5.1. Extinguishing media

Exposure hazards: Highly flammable. In combustion emits toxic fumes. Forms explosive air-vapour mixture.

Vapour may travel considerable distance to source of ignition and flash back.

5.3. Advice for fire-fighters

Advice for fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes. Keep containers cool by spraying with water if exposed to fire.
