EMISSIONS REDUCTION TARGETS

In order to continue our progress to achieving net zero, we have adopted the following carbon reduction targets. We project that carbon emissions will decrease over the next seven years to **2,692.8** kgCO₂e by 2030. This is a reduction of **20%** progress against these targets.

CARBON REDUCTION PROJECTS

COMPLETED CARBON REDUCTION INITIATIVES

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to 3,228kgCO₂e, a 4.1% reduction against the 2021 baseline and the measures will be in effect when performing the contract.

- Environmental objectives set and achieved in 2028
- Significant reduction of business mileage in 2023 compared to the 2022 figure
- Replacing company car(s) with PHEV or EV in 2024
- Contracting with recycling initiatives in place and to continue
- In the future we hope to implement further measures such as:
 1. Reduction of water consumption at business locations.
 2. Increased recycling at business locations
 3. Move to renewable energy sources where possible at business location.
