A 12-Month Warranty applies for all Barneys brand furniture & equipment products including the following:

- LED Magnifying Lamps
- Beauty Trolleys

## A 24-Month Warranty applies specifically to Adjustable Electric Beauty Beds:

- This warranty is not transferable

If your product is within the Warranty period and you believe it could be a manufacturing or material fault, contact the place of purchase or Beauty Brands Group. All products considered to be faulty must be returned for assessment to Beauty Brands Group Pty Ltd before the Warranty can be confirmed. <u>DO NOT return products without prior approval.</u> Once Beauty Brands Group has registered and approved return of your product it can be returned to BBG, check for our correct address details. Beauty Brands Group does not cover the cost of shipping. If Warranty is approved your product will be repaired or replaced as soon as is possible.

If return of your product has been approved for assessment please ensure that it is packaged carefully as items damaged in transit will not be covered by Warranty and Beauty Brands Group will not cover repair costs. Please photograph your product prior to packaging and forward to BBG along with your Warranty application.

**IMPORTANT:** Include a copy of your original invoice and current contact details with the goods returned. We strongly recommend using a shipping provider with ability to provide tracking, record the tracking number. Beauty Brands Group will not be liable for any products lost in transit.

Any repairs not covered under warranty need to be paid before your product can be returned.

If your product is covered under Warranty Beauty Brands Group will cover the return shipping cost(s). If repairs are not covered under Warranty you will need to pay for return shipping before the product can be shipped.

This Warranty is subject to the Australian Competition and Consumer Act 2010 (Australian Consumer Law). The benefits provided in this Warranty are in addition to other rights and remedies of a consumer under the Australian Consumer Law, and any other laws in relation to the products to which this warranty relates. The warranty period commences from the date that goods are purchased for a period of 12-Months.
