Terpenes are natural oils, and depending on the strain of hemp, the terpene profile varies. Terpenes have potential therapeutic capabilities, so it's good to know which ones are present in the product you ingest.

- PESTICIDES**

Our hemp is grown in organic soil, and we make sure that there are no pesticides present in our products.

- MICROBIOLOGY SCREENING**

We test for harmful contaminants to ensure the safety and purity of our products.

- RESIDUAL SOLVENTS**

Solvents are chemicals oftentimes used during the extraction of cannabinoids and terpenes. Our extraction process is solvent-free, which we confirm through testing.
