Ashdown Design & Marketing Ltd. expects our suppliers and business partners to be aware of their obligations under REACH and expects any substances or products within the scope of REACH to be pre-registered before December 1, 2008. Given those conditions, our current products are exempt from REACH pre-registration and later registration activities.
