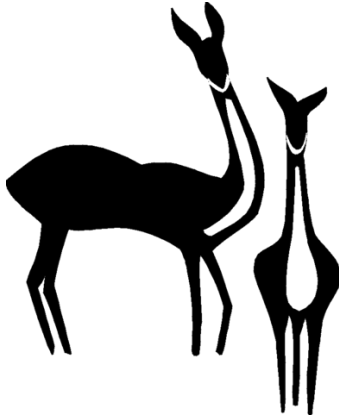

In order for us to process your registration in a timely manner, **please register no later than December 31st.**

PAYMENT PLANS:

You may pay in FULL, or on a QUARTERLY or MONTHLY basis. If you pay in Full, you will receive a 5% discount. Should you choose to make quarterly or monthly

payments, please use the **NON** Pay Pal option at check out. The credit card you use to make the first payment is the card we will use to schedule your future payments.

The Monthly Payment Schedule is as follows:

1st Payment due by November 15
2nd Payment due by December 15
3rd Payment due by January 10
4th Payment due by February 15
5th Payment due by March 15
6th Payment due by April 15
7th Payment due by May 15
8th Payment due by June 15
9th Payment due by July 15
10th Payment due by August 15

If paying monthly –Level rates are **based on a 10 month payment plan that begins on November 15**. So, if you are joining us later than that, your payments will be adjusted accordingly (in other words two months of payments are due by December 15, and so on).

The Quarterly Payment Schedule is as follows:

1st Quarter Payment due by January 10
2nd Quarter Payment due by March 15
3rd Quarter Payment due by June 15
4th Quarter Payment due by August 15

Recurring Payments

Once you are directed to the payment page you will be able to choose your payment option. ***You will be placed automatically on a recurring payment schedule if you chose either to pay monthly or quarterly. Please use the NON Pay Pal option at check out. The credit card you use to make the first payment is the card we will use to schedule your future payments.***

Additional Important Information

FINANCIAL STATEMENTS:

You will receive a financial statement once a year from Lynn Andrews Productions reflecting all payments that we have received up to the date of your statement. Statements will be emailed out in the fall.

REFUNDS:

Based on the Level of participation you choose. Requests for a refund must be sent in writing. If your request is approved, it will be refunded per the time of year.

TO PAY BY CHECK:

You may pay by check to pay the annual fee in full. You may not pay by check to take advantage of payment programs.
