### **Interpretation**

The following definitions shall have the same meaning regardless of whether they appear in singular or in the plural.

### **Definitions**

For the purposes of this Return and Refund Policy:

- \* You means the individual accessing or using the Service or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.
- \* Company (referred to as either “the Company”, “We”, “Us” or “Our” in this Agreement) refers to Paddock Blade Australia Pty Ltd, PO BOX 2626 Caulfield Junction.
- \* Service refers to the Website.
- \* Website refers to Paddock Blade Australia, accessible from [www.paddockblade.com.au](http://www.paddockblade.com.au)
- \* Goods refer to the items offered for sale on the Service.
- \* Orders mean a request by You to purchase Goods from Us.

## **Your Order Cancellation Rights**

You are entitled to cancel Your Order within 30 days.

The deadline for canceling an Order is 30 days from the date on which You received the Goods or on which a third party you have appointed, who is not the carrier, takes possession of the product delivered.

In order to exercise Your right of cancellation, You must inform Us of your decision by means of a clear statement. You can inform us of your decision by:

We will reimburse You no later than 14 days from the day on which We receive the returned Goods. We will use the same means of payment as You used for the Order and You will incur a 10% handling and restocking fee for such reimbursement.

### **Conditions for Returns**

In order for the Goods to be eligible for a return, please make sure that:

- \* The Goods were purchased in the last 30 days
- \* The Goods are in the original packaging
- \* The Goods are in good working order with no damage

The following Goods cannot be returned:

- \* The supply of Goods made to Your specifications or clearly personalized.
- \* The supply of Goods which according to their nature are not suitable to be returned, deteriorate rapidly or where the date of expiry is over.
- \* The supply of goods which are not suitable for return due to health protection or hygiene reasons and were unsealed after delivery.
- \* The supply of goods which are, after delivery, according to their nature, inseparably mixed with other items.

We reserve the right to refuse returns of any merchandise that does not meet the above return conditions in our sole discretion.

### **Returning Goods**

You are responsible for the cost and risk of returning the Goods to Us. You should send the Goods at the following address:

We cannot be held responsible for goods damaged or lost in return shipment. Therefore, We recommend an insured and trackable mail service. We are unable

to issue a refund without actual receipt of the Goods or proof of received return delivery.

## **Gifts**
