Minimum Tab

We'll keep a tab open for you during your event to allow your guests to order beer as they choose, and will add a standard 20% tip to the tab at the end of your event. Your minimum tab (Beer + Gratuity + Rental Fee + Deposit) must meet the minimums outlined in the Fee Schedule above. **We will charge you the agreed upon minimum tab should your tab not meet the outlined minimum.**

Minimum Tab Example

Let's say you rented the back room for 3 hours on a Wednesday. Your minimum tab would break down like so:

Deposit: \$100

Rental Fee: \$200 (\$300 minus Deposit)

Beer: \$160

Gratuity: \$40 (20% of \$200)

Minimum Tab: \$500

As you can see, your Rental Fee and Deposit are counted towards your Minimum Tab, as are Beer and Gratuity.

Cancellation

Sometimes life derails our plans. It's cool. You can cancel up to 48 hours prior to your event for 50% of the minimum tab for that particular day of the week unless your event can be rescheduled within 6 months of the original date.

Using our previous example, if you had planned on renting the space on a Wednesday for 3 hours but were forced to cancel, you'd be responsible for a total of \$250 for your cancellation. \$100 would be applied from your deposit which would leave you responsible for \$150.

Outside Alcohol

South Carolina law prohibits us from buying or serving liquor in our brewery. That said, we do know vendors who we can introduce you to who would be happy to provide liquor service for your event. These vendors are legally allowed to sell and serve liquor inside our facility should you require it.

Please note that outside liquor service requires an additional contract on top of our standard event agreement, and does not count towards the minimum tab fee outlined above.
