Vendor Contract

CAREFULLY READ THE FOLLOWING AND INITIAL EACH ITEM:

- ___ Vendors must display their own work. Mass produced or manufactured items are not allowed.
- ___ Direct sales or Multi-Level Marketing (network or referral marketing) items are not allowed.
- ___ Wells Family Christmas Tree Farm is a family environment. All displays/items must be appropriate for all ages.
- ___ No food or drink sales/giveaways will be permitted. We will have food trucks on site.
- ___ The Oklahoma State Tax Commission requires ALL vendors to fill out a sales tax form the day of the market and turn in to Wells Family Christmas Tree Farm **WITH PAYMENT—CHECK ONLY—**before leaving the farm. The form will be provided to you on the day of the market. Checks must be made payable to Oklahoma Tax Commission.
- ___ If you require electricity, QUIET generators are allowed. Please bring an extension cord so the generator can be moved away from the booths.
- ___ If you require electricity and do not have a generator, Wells Family Christmas Tree Farm can provide electricity to your booth for \$10. YOU MUST PROVIDE YOUR OWN OUTDOOR EXTENSION CORD.
- ___ Vendors have the option to set their booths up the day before the market. THIS IS STRONGLY RECCOMENDED. All booths need to be set up no later than 9:00 A.M. the morning of the event.
- ___ Booths must remain open and staffed the entire day of the market.
- ___ Wells Christmas Tree Farm has permission to use images of the vendors, products, booths and names to promote the event.
- ___ The market will be held rain or shine. Vendor fee refunds will not be issued for any reason.
- ___ Wells Family Christmas Tree Farm reserves the right to deny an application for any reason. (Vendor fee will be refunded if application is not accepted.)
- ___ Vendor must clean up and take ALL items from booth area by 7:00 P.M. the day of the event. This includes ALL trash, products, items, tents, etc. Leaving trash or any items at the farm will forfeit any future participation in the market.
- ___ I agree to hold harmless Wells Family Christmas Tree Farm, its employees and volunteers, Jesse Wells or Katy Wells from any injuries to myself or anyone working with or for me, and/or any damage or loss to any of my property.
