**Commercial Agreement**

The undersigned (hereinafter "Applicant") authorizes the use of a facsimile of this document as a verification of release of information by references to the seller. The Applicant further agrees that this agreement may be executed by means of a photocopied or fax signature. The signature shall be effective, valid and enforceable as if it was an original signature.

The terms and conditions of this application shall, upon extension of credit to the Applicant by Copper Creek Hardware Inc. and its successors and assigns (hereinafter the "Seller") constitute a credit agreement between Applicant and Seller (hereinafter this "Agreement") and shall take precedence over and supersede any and all conditions set forth by Applicant's purchase order, whether the order is written or verbal. Should credit be granted by Seller to Applicant, all credit shall be extended at the sole discretion of the Seller. Seller may increase or limit any credit availability at any time within its sole discretion. No liability or damage claim is created from any such limit or change in the amount of credit authorized to the Applicant. Upon execution of this credit application, the initial "Credit Limit" will be set at \$20,000 (Twenty Thousand dollars). The Applicant shall not incur credit in excess of this amount authorized by Seller.

Our standard payment terms are 2% 15, net 30 days unless otherwise agreed upon between Applicant and Seller. Applicant will receive a 2% discount on net total of invoice if payment is received no later than 15 days past invoice date. If payment is received 16 days or more past the invoice date the original invoice amount will be due and no discount will be offered. In any event the invoice must be paid within 30 days for the account to remain in good standing and any such invoices not paid are then considered delinquent on the 31st day after invoice date. No other terms will be accepted even if written on any purchase order unless authorized in writing by Seller. The Applicant agrees to pay Seller a monthly 1-1/2% service charge on any delinquent accounts, all collection fees and reasonable attorney fees associated with collecting

The Seller expressly excludes and disclaims all warranties, expressed or implied including, without limitation any implied warranty of merchantability or fitness for a particular purpose. The Seller's liability is limited under any and all circumstances to the purchase price of any products sold to the Applicant. Under no circumstances will the Seller be liable for any incident or consequential damages, or for any loss, damage or expense of any kind including loss of profits arising in connection with the use or inability to use any products furnished or to be furnished by the Seller.
