

## DISCOUNTER\$ DOLLAR\$ PROMOTION – OFFICIAL RULES

**PROMOTION DESCRIPTION.** The DISCOUNTERS DOLLARS promotion at Discounter's Pool & Spa Warehouse provides participants the chance to match & win instant cash rebate prizes at participating Discounter's Pool & Spa Warehouse locations. The promotion begins 9 AM April 25 to 6 PM April 28, 2019. No purchase necessary.

**ELIGIBILITY.** Each person who participates in the promotion fully and unconditionally agrees to comply with and abide by these Official Rules and the decisions of Discounter's Pool & Spa Warehouse, whose decision shall be final and binding in all respects. The promotion is open only to legal residents of Ontario. Persons in any of the following categories are NOT eligible to participate or win prizes in the promotion: (a) any person who is a director, officer, employee, agent or suppliers, or any of their respective divisions, parent, subsidiary, or affiliated companies, or service agencies, or independent contractors of any of the above organizations; (b) individuals engaged in the development, production or distribution of materials for the promotion; and (c) persons who are immediate family members of any person in any of the preceding categories, regardless of where they live in any of the preceding categories. The transfer of promotion materials by any person in any of the preceding categories to an eligible person is strictly prohibited. If any potential winner declines a prize or is found to be ineligible, or if he/she fails to comply with these Official Rules, such potential winner will be disqualified and will forfeit the prize he or she otherwise might have received.

**HOW TO WIN.** Bring your specially marked CLOSED DOOR SALE INVITATION to a Discounter's Pool & Spa Warehouse between 10 AM April 25 to 6 PM April 28, 2019 to reveal if the invitation is a potential winner. If the invitation is a winner of an instant cash rebate prizes identified in these Official Rules, then the participant is entitled to redeem the DISCOUNTER\$ DOLLAR\$ rebate value at the time of purchase or accept a Discounter's Pool & Spa Warehouse credit note. The winning invitation is subject to verification and must be surrendered to claim prize and compliance with these Official Rules. A participant is not a winner of any prize until the winning invitation and the participant's compliance with these Official Rules have been verified by an authorized Discounter's Pool & Spa Warehouse manager.

### PRIZE DETAILS.

All stated values of prizes are the rebate value ("RV"). Stated odds of winning are as of the commencement of the promotion. Approximately 74,000 invitations will be distributed. Overall odds of winning a prize are approx. 1 in 64.

**GRAND PRIZES** (RV \$500). 3 prizes are available to be won. Overall odds of winning are approx. 1 in 24,666.

**SECOND PRIZES** (RV \$100). 25 prizes are available to be won. Overall odds of winning are approx. 1 in 4933.

**THIRD PRIZES** (RV \$50). 100 prizes are available to be won. Overall odds of winning are approx. 1 in 1480.

**FOURTH PRIZES** (RV \$20). 200 prizes are available to be won. Overall odds of winning are approx. 1 in 740.

**FIFTH PRIZES** (RV \$10). 1170 prizes are available to be won. Overall odds of winning are approx. 1 in 74.

### PRIZE RESTRICTIONS.

Prizes will be awarded only if a participant fully complies with these Official Rules. Prizes must be accepted as awarded. No refunds, cash alternative or substitution of any prize will be provided. Any unused DISCOUNTER\$ DOLLAR\$ will be converted to a store credit. All taxes (including, without limitation, federal and provincial taxes) on or connected with any prize are the sole and exclusive responsibility of respective winners, unless expressly stated otherwise.
