'Drop and Go' Consignment Agreement

Drop off process: Once you have dropped off your clothing, your items will be set aside for our sorters who will sort through and select suitable items for sale. Anything that they feel is unsuitable for sale will be automatically forwarded to charity for you without further notice. We are highly selective based on customer preferences, so we accept clothing less than 3 years old. We do not accept George, Old Navy or Liz Lange. H&M, Thyme, Motherhood is only accepted by exception and in like-new condition. Please ensure you only bring in your best pieces for consignment. I agree to this policy_____ Initial

Consignment Period: The consignment period is for a maximum of 60 days from the time the item is processed. It is the consignor's responsibility to remember their contract expiration, we do not contact consignors to notify of account status. While we have great consignment turnover, we cannot guarantee sales of every piece and we are unable to hold items for return. Unsold items become property of Baby & Me for disposal at our discretion. We are pleased to support the Canadian Diabetes Association, Pregnancy Care Centre & other local charities with donations. Seasonal Deadlines: You're welcome to drop anytime, however, for best consignment results please allow your pieces time to sell or hold off for the next season. Earliest drop-offs give best returns. We pull and donate any unsold seasonal pieces at the end of the seasonal deadlines. ***Spring & Summer: March 1 to August 31* *Fall & Winter: September 1 to February 28*** I agree to this policy_____ Initial

Pricing: Items are priced at 25-50% of retail price and vary depending on the condition, style, age AND on desirability. We will try to get the best possible prices for you. Any items that are price sensitive should be mentioned to staff at drop off. A \$0.99 handling fee will be applied to each item to cover the costs of processing, tags and handle time. This fee is passed onto the buyer and is not split with the consignor. From time to time, Baby & Me will have sales and markdown items to attract customers and move merchandise, this may affect the price of your pieces. Markdowns and discounts are to be shared equally between Baby & Me and consignor. I agree to this policy_____ Initial

Payment: Consignors receive 30% of the final selling price. Payouts are generated upon request. Payments must be picked up in-store otherwise, there is a \$2.00 fee deducted from your balance per mailed cheque or EFT. Account balances that are not claimed within 1 year of activity are forfeited. I agree to this policy_____ Initial

Liability: We will do our best to safeguard your items, but items must be left at your own risk. We are not responsible for damage or loss due to theft, fire, natural disaster or any other unforeseen circumstance. I agree to this policy_____ Initial
