

Terms and Conditions of Entry – Shriro Australia Blanket Promotions 2017-2018

General

1. Information on how to enter, dates and prizes as set out in the Schedule form part of the Terms and Conditions of Entry (**Terms and Conditions**) for each competition conducted under the Blanket (each a **Competition**). Entry into this Competition deems acceptance of these Terms and Conditions.
2. To the extent of any inconsistency between these Terms and Conditions and any other reference to this Competition, these Terms and Conditions prevail.

Who can enter

3. Subject to any age restriction specified in item 1 of the Schedule, entry is open to all residents of Australia who fulfil the requirements set out below.

How to enter

4. Entrants may enter this Competition by following the entry requirements set out in Item 2 of the Schedule. Conditions specific to the method of entry are set out in Item 2 of the Schedule.
5. Entries must include all requested contact details, including a valid email or postal address (as requested), to be eligible to win. Entrants may only enter in their own name. Inaudible, incomprehensible, illegible, and incomplete entries will be deemed invalid.

Number of Entries permitted

6. Entrants may enter this Competition as often as is specified in Item 3 of the Schedule.

Open, Close, Draw and Publish dates

7. The Competitions conducted under this Blanket commence on **09/09/2017 at 12:01 AM AEST/ AEDT** and closes on **08/09/2018 at 11:59 PM AEST/ AEDT**. (**Blanket Promotional Period**). Entries for each Promotion must be received by the Promoter prior to the Competition close date and time. The final draw will occur no later than **09/09/2018 at 11:00 AM AEST/ AEDT**.
8. Each individual Competition conducted under the Blanket will open, close and be drawn on the date specified in Item 1 of the Schedule. All draws will be conducted at the premises of Permutz Group Pty Ltd at 3.11/4 Ilya Avenue, Erina 2250 NSW or the Promoter's Premises.
