

**Information & Instructions: Application And Order To Pay Fee In Installments**

**PREVIEW**

1. This form includes an acknowledgment by the debtor that the case can be dismissed if the debtor fails to pay any installment.
2. It also clarifies the fact that payment to a bankruptcy petition preparer does not relieve the debtor of paying the remaining installment payments for the filing fee.
3. The debtor cannot make more than four installments and the final payment must be paid no later than 120 days after the filing of the petition.
4. For good cause shown, the court can extend the time of payment but no later than 180 days after the filing date, see Fed. Bank. R. P. 1006(b)(2).
