

Information or instructions: Answers to interrogatories

PREVIEW

1. TRCP Rule 197.2 governs the response to a party's interrogatories.
2. The following form may be used by the responding party.
3. The interrogatories shall be answered separately and fully in writing under oath.
4. Each answer must be preceded by the question to which the answer pertains.
5. Per TRCP Rule 197.2(d) the answers shall be signed and verified by the person making them.

6. **PLEASE DO NOT COPY**
 - a. when the answers are based on information obtained from other persons, the party may so state and
 - b. a party need not sign answers to interrogatories about persons with knowledge of relevant facts, trial witnesses, and legal contentions. TRCP 197.2(d)
7. Written objections to one or more of the interrogatories must be made within thirty (30) days after service.
