

Information or instructions: ~~Plaintiff's motion & order for a preferential trial setting~~

PREVIEW

1. The purpose of a motion for preferential setting is to advance the case's position on the trial docket so that it may be reached for trial during the week designated in the setting.

2. Most court dockets are based upon the chronological age of the case number; accordingly, the older the case number, the sooner it will be reached for trial on the court's docket. Preferential setting allows the plaintiff to have the case tried regardless of the chronological order of the case number.

3. See the court's local rules for the procedure applicable to granting preferential settings. Some local rules provide the following reasons to justify granting the preferential setting:

This case has been on the docket for over two years;

- b. Out of town witnesses will be called;
- c. Injunctive relief has been granted against one of the parties to the action and the Movant suffers from hardships which stem from the injunctive relief;
- d. Good cause shown to the court.
