## Information or instructions: Plea in abatement motion & Order to quash service Alternate Form

- 1. The following form may be used to request the court to cancel or quash service of citation on a party and to abate the cause of action.
- 2. The motion is frequently used when the service has been issued improperly or served on the incorrect party to the lawsuit. It should show who the proper party to the lawsuit is.
- 3. The purpose of a plea in abatement is to dismiss Plaintiff's cause of action or abate it for any one or more of the following reasons: lack of jurisdiction, running of the statute of limitations, failure to state a cause of action, filing in the wrong court, or suit against defendant in an incorrect legal capacity.
