

Foreign limited partnerships

PREVIEW

1. A foreign limited partnership is a partnership that has as members, one or more general partners and one or more limited partners, that has been formed under the limited partnership laws of any territory, possession, commonwealth or state of the United States other than the state of Texas.

2. A foreign limited partnership is governed by the laws of its state of formation with regard to organization, internal affairs and liability of its partners.

3. A foreign limited partnership must conform to the Texas Business Organizations Code provisions regarding the type of business conducted and the general administrative provisions regarding registered offices and agents, and the filing of certificates and other required instruments.

4. Before transacting business in Texas, a foreign limited partnership must register with the Secretary of State by paying the required filing fee and delivering the original and one copy of an application for registration as a foreign limited partnership executed by a general partner.

5. Matters to be included in statement of qualification for a foreign limited partnership include the following information:

a. the limited partnership's name, jurisdiction of its formation, and address of its principal place of business,

b. the state that it was formed in,

c. a statement from a general partner as to the limited partnership's filing date and that it validly exists as a limited partnership in that state,

d. the nature of the business to be conducted in Texas,

e. the registered agent's name and address,

f. that the secretary of state is appointed as the agent for service of process upon withdrawal from doing business in Texas,

g. the name, the mailing address, and street address of the residence or business of each general partner, and

h. the date on which the foreign limited partnership first transacted or intends to transact business in Texas

Statement of qualification of foreign limited partnership, now known as an application for registration of a foreign limited partnership

PREVIEW

1. A qualified foreign limited partnership and the general partner(s) named in its application may change the registered office or the registered agent, or both, by filing with the Secretary of State a statement designating the new office address or agent, and paying a filing fee of \$50.
2. A qualified foreign limited partnership may change the general partner(s) named in its qualification statement by filing with the Secretary of State a statement (signed by the partnership and by the general partner(s) who will thereafter be the named partner(s) designating the named general partner(s) and containing his or her or their consent to be served with process in Texas through the limited partnership's registered agent in any proceeding for the enforcement of an obligation of the limited partnership, and paying a fee of \$50.
