



# Harbor

The nautical character of a Scandinavian harbor inspired this floor's rustic style. Oak is smoked to achieve an ashen grey tone, reminiscent of old-world wood planks. This smoking technique lets the cooler tones of the underlying wood shine through. With beveled edges on all four sides, this floor has a classic Scandinavian wide-plank look and is hand-scraped for a worn and raw texture.
