**(Base 30mil Coating with embedded reinforcement fabric)**

Warranty can be extended for an additional 10 years by applying a 15-mil maintenance coat at the end of each 10 year warranty period for a total of 30 years per application instructions.

**Limitations:** Subject to the terms. Limitations and conditions contained within this warranty. Dura-Rubber!™ shall replace defective material.
