

D8-THC and exo-THC). ND = None detected above the limits of detection (LOD), which is half of LOQ.

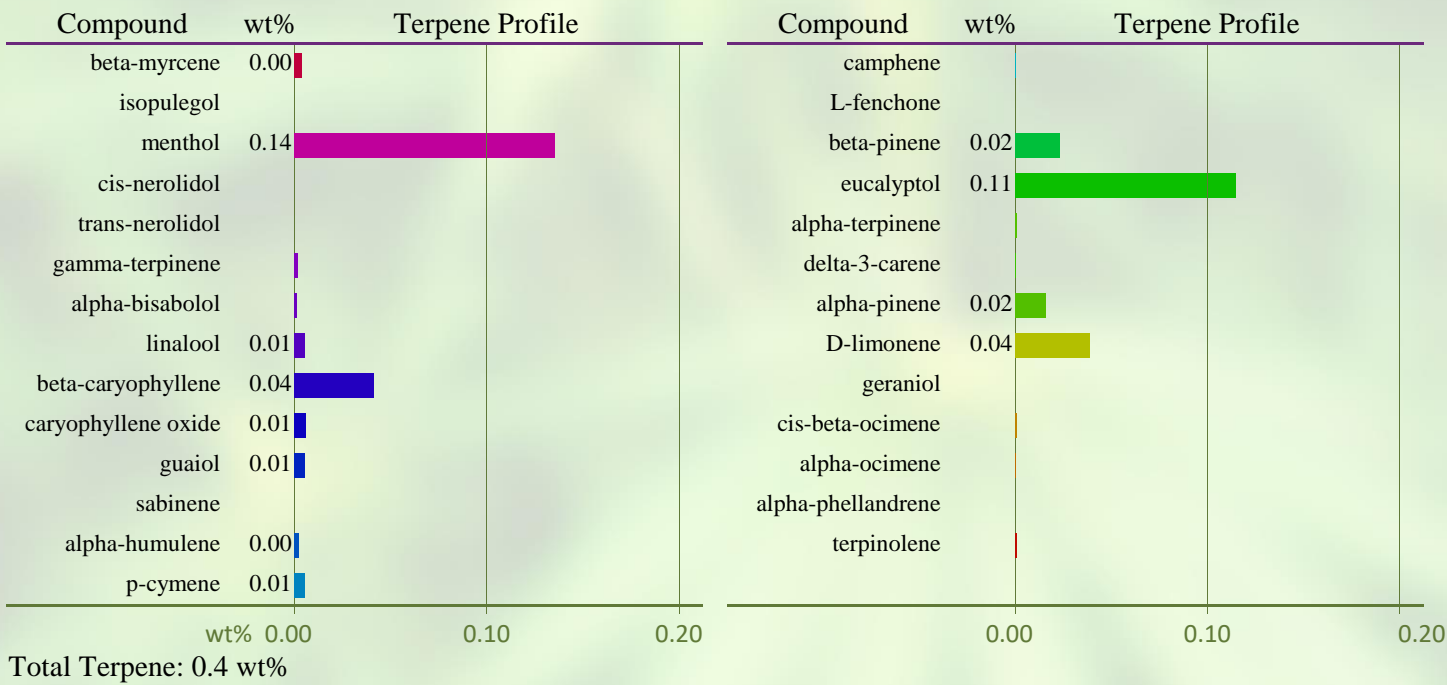
**TP: Terpenes Profile [WI-10-27]**
