NIOSH Certified N95 Respirator

While single layer nuisance dust masks can help keep you safe during light construction or cleaning activities, they offer little protection against very small particles traveling through the air, like germs from a cough or sneeze, or fine non-poisonous dusts. For protection against small particles, a mask with filtration material, a particulate respirator is often required. The most popular of particulate respirators approved by the National Institute for Occupational Safety and Health (NIOSH) is the N95 mask, labeled N95 for their 95% efficiency rating. The N95 masks can filter particles of 0.3 microns.



NIOSH and the Centers for Disease Control and Prevention (CDC) recommended N95 masks for protection of healthcare workers who come in direct contact with patients with H1N1 and other airborne viruses.

Vizocom's N95 Respirator masks conforms to NIOSH standards. Our Disposable N95 mask provides protection against solids such as minerals, coal, iron ore, flour and certain other substances. They are extremely durable, have a soft and comfortable inner surface, an adjustable nose piece and secure head straps to provide proper fit.
