## Tat-Targa Boarding Kennels Policies and Agreement.

1. **Tat-Targa Boarding Kennels** reserves the right to immediately change your pet's type of boarding if we believe it is necessary to protect the health and well-being of your pet, other pets, or our staff.
2. All pets must be healthy and have apparent up to date vaccinations. You will be required to bring your pets' **UPDATED** vaccination records from your vet before you start boarding with us to ensure your pets' safety as well as that of our current borders.
3. If your pet is exhibiting any symptoms of flea or tick problems he will be bathed at the owner's expense.
4. Check in and check out is Monday to Friday from 10:00 till 16:00. Saturday, Sundays, Public holidays and all month of August from 10:00 till noon. Pet dropped off before or leaving after opening hours are charged **15 EURO** extra for every pet at our discretion. **PEAK SEASONS are charged according to booking dates.**
5. The client undertakes to pay the daily rate of \_\_\_\_\_ euro (inclusive of vat). This payment is calculated from the day of entry until the day the pet leaves the premises, and even a part of a day is considered as a full day.
6. Payment is required upon your pet(s) arrival.
7. The house brand of dog and cat food is Arden Grange. Brands like Royal Canine and Whiskas are also fed. Should you feed on other food or medicated diet, this should be provided by the client.
8. Owners are to bring their own bedding and toys for their pets. Please make sure that all are animal-friendly.
9. Owners are agreeing to board two or more pets of their own in a cattery/kennel and permitting them to play together. They are also aware that nicks and scratches may occur.
10. Pets may be videotaped, photographed, and/or recorded. These may be used in any Tat-Targa Boarding Kennels promotion, advertising or publicising materials.
11. In the event that the pet should become ill or die whilst at **Tat-Targa Boarding Kennels**. The Operator (Tat-Targa Boarding Kennels) shall not be liable for any damages unless it can be shown that there was negligence on the part of the Operator. In the event of the pet dying, the Client is authorising the Operator to carry out a post-mortem examination of the pet by a veterinary surgeon of its choice, such post mortem to be paid by the client, in order to determine the cause of death. After the post mortem, the Operator is authorised to dispose of the pet as considered fit.

The decision of the veterinary surgeon shall be final & binding on both parties to this agreement. In the event that the damages should be paid by the Operator to the client, it is hereby agreed & accepted by both parties to this agreement that these damages cannot exceed Five hundred and Eighty-Three euro (583euro)

12. The Client undertakes to collect his/ her pet on \_\_\_\_\_(termination date)

If after three days from termination date of this agreement the client fails to collect the pet, **Tat-Targa Boarding Kennels shall have the right to dispose of the pet in any way deemed fit, including & if so required, to have the pet put down, any expenses incurred by Tat-Targa Boarding Kennels in disposing of the pet shall be at the charge of the client.**
14. Neglect or failure by **Tat-Targa Boarding Kennels** to enforce any of its rights under this agreement shall & cannot be interpreted as a waiver to any rights & shall therefore not prejudice or effect any of its rights to enforce this agreement.
