<b>IFRA CLASSES</b>	<b>FINISHED PRODUCT TYPES</b>
<b>CLASS 1</b>	Lip products of all types (solid and liquid lipsticks, lip balms coloured and clear, lip products containing sunscreen, lip scrubs etc.).
<b>CLASS 2</b>	Products applied to the axillae, deodorants (spray, stick, roll-on etc.), anti-perspirants, solid deodorant balms. Body sprays, including body mist.
<b>CLASS 3</b>	Eye products of all types (eye shadow, mascara, eyeliner, eye masks, eye cream and moisturisers, eye serums etc.). Make up remover for eyes and face. Facial makeup and foundation. Nose pore strips. Wipes, or refreshing tissues for face, neck, hands, and body. Body and face paint (for children or adults). Facial masks for the face and around the eyes.

<b>CLASS 5C</b>	Hand creams. Nail care products, including cuticle oils and creams. Hand sanitisers
<b>CLASS 5D</b>	Baby creams, lotions, oils, powders and talc
<b>CLASS 6</b>	Toothpaste. Mouthwash, including breath sprays. Toothpowder, strips and mouthwash tablets
